Additionally, Acting Chief Wagaman attended Del Campo High School where they recognized Cameron Pascual for saving his father's life. Since Cameron was part of the fire technology program at Del Campo, this recognition at school was very well received by the 1,800 students.

Lastly, Chief Wagaman recognized the firefighters for working in extreme heat and fighting several fires this week. Everyone has been staying hydrated and healthy while keeping the community safe. Job well done!

OPERATIONS' REPORT

Deputy Chief Mitchell reported statistics since the last Board meeting on August 25th, with 4,177 total incidents; just under 300 calls per day. There were 177 fire incidents, an average of 12.6 calls per day.

The Service Delivery Team met yesterday morning and discussed the plan for next steps on the team. Chief Rudnicki is moving to the EMS sub group co-chair position, Chief Russell is moving to the Special Ops co-chair position, Chief Lozano is remaining as the co-chair for suppression, and DC Mitchell will be moving to the Service Delivery Team co-chair position with Firefighter Gildone. Thanks to all of those that have participated to get us this far, and we look forward to what the team brings forward next.

Deputy Chief Mitchell shared information about the Madison Avenue After Action Review Video and release to the media. A number of responders from both Metro Fire and the Sacramento County Sheriff Office worked together to provide this valuable awareness and educational video

for release. This was an incredibly complex incident with many difficult decisions that ended up with a rescue of two people. We are very proud of their efforts. More to come on recognition of those members involved on the scene.

DC Mitchell shared some general operational information with members' recent deployments at the Mosquito Incident with the OES engines, copter, and Single Resource IMT. Also, we have a member in Yosemite as part of an IMT. A-Shift worked Monday and Tuesday in record setting high temperatures. During this time our crews performed at the high level of professionalism we expect. During these two days our crews faced three working structure fires involving residential occupancies. We also had numerous other fires that were on a smaller scale, medic unit drawdown issues due to heavy call volume, and Strike Team and IMT deployment on night two. CERT was available for rehab and did deploy on a fire in B9, as did our reserve firefighters on multiple incidents. B shift has been busy for the last day and a half as well while the high temps continue, and our members continue to perform at a high level of professionalism.

Lastly, on August 21st, E28 and M21 responded for a 69 year old female who was found to be in Super Ventricular Tachycardia after assessment. Upon recognition of the critical situation, members delivered 6 shocks, with base contact, and the patient's rhythm final converted to a heart rate of 90 with a BP of 100/64, and skin signs improved. Delivering energy to a conscious and awake patient is a tough procedure to perform in the field, but understanding the importance to improve the patient condition is key. Kudos to Firefighter Adam Rosen, Firefighter Nick Wanner, Firefighter John Ten Brinke, Engineer Tim Eisert, and Captain Eric Alekman for performing professional treatment in a difficult circumstance.

3. SMFD – FIREFIGHTERS LOCAL 522 REPORT

President Trevor Jamison reported out for VP Cole, as he is traveling. While FF Jamison represents all 522 members, he is incredibly proud to be a member of Metro Fire. He wished Joanna Navarro and Chris Dargan well one their future endeavors, and congratulated Brenda Briggs on her promotion. Two members left Metro Fire to go to other agencies, and we wish them well also.

He congratulated Tim White and Scott Schneider for the success of the Del Campo Fire Technology program. In fact, he was working at a firehouse recently and two students from the program stopped by for a station tour.

Lastly, he asked for a moment of silence honoring Matthew Clapsaddle from Ventura City Fire, who passed away suddenly on August 20th.

RESOLUTION NO. 2022-

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SACRAMENTO METROPOLITAN FIRE DISTRICT PROCLAIMING A LOCAL EMERGENCY, RE-RATIFYING THE PROCLAMATION OF A STATE OF EMERGENCY BY GOVERNOR GAVIN NEWSOM MARCH 4, 2020, AND AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF THE LEGISLATIVE BODIES OF THE SACRAMENTO METROPOLITAN FIRE DISTRICT FOR THE PERIOD OF SEPTEMBER 22, 2022 – OCTOBER 21, 2022 PURSUANT TO BROWN ACT PROVISIONS.

WHEREAS, the Sacramento Metropolitan Fire District is committed to preserving and nurturing public access and participation in meetings of the Board of Directors; and

WHEREAS, all meetings of the Sacramento Metropolitan Fire District's legislative bodies are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963), so that any member of the public may attend, participate, and watch the District's legislative bodies conduct their business; and

WHEREAS, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, a proclamation is made when there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the jurisdictions that are within the District's boundaries, caused by natural, technological, or human-caused disasters; and

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, meeting in person would present imminent risk to health and safety of attendees; and

WHEREAS, the Board of Directors does hereby find that conditions causing imminent risk to attendees has caused, and will continue to cause, conditions of peril to the safety of persons within the District that are likely to be beyond the control of services, personnel, equipment, and facilities of the District, and desires to proclaim a local emergency and ratify the proclamation of state of emergency by the Governor of the State of California; and

WHEREAS, as a consequence of the local emergency, the Board of Directors does hereby find that the legislative bodies of the Sacramento Metropolitan Fire District shall conduct their meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that such legislative bodies shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and

WHEREAS, all meetings will be held in a virtual manner where the public may access them via the virtual platform with all login information provided on each board meeting agenda.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE SACRAMENTO METROPOLITAN FIRE DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Recitals. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

Section 2. <u>Proclamation of Local Emergency</u>. The Board hereby proclaims that a local emergency now exists throughout the District, and meeting in person would present imminent risk.

Section 3. <u>Ratification of Governor's Proclamation of a State of Emergency</u>. The Board hereby re-ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of its issuance date of March 4, 2020.

Section 4. Remote Teleconference Meetings. The staff and legislative bodies of the Sacramento Metropolitan Fire District are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.

Section 5. Effective Date of Resolution. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of (i) October 21, 2022, or such time the Board of Directors adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the legislative bodies of the Sacramento Metropolitan Fire District may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.
