#### **CALL TO ORDER**

The meeting was called to order at 6:00 pm by President Jones. Board members present: Barnes, Clark, Goold, Jones, Kelly, Orzalli, Saylors, Sheetz, and Wood. Board members absent: None. Staff present: Chief Harms, Clerk Penilla and General Counsel Lavra.

(Firefighters Burn Institute Executive Director, Mike Daw)

#### **ACTION ITEM**

1. Sale of Real Property - Station 33, 5148 Main Avenue, Orangevale CA

(Economic Development Manager, Jeff Frve)

Recommendation: Authorize the Fire Chief to effect the sale of the property to the highest preferred offeror, or second highest preferred offeror, in such an instance that the first preferred offer falls out of escrow. Both offers complied with Metro Fire's requirements, and removed all contingencies.

After a presentation from Economic Development Manager Frye, President Jones opened the floor up to questions and comments from Board Members. Director Kelly inquired about the parcels and acreage. Mr. Frye explained this property consists of three attached parcels, totaling seven acres, which is zoned open space as park and recreation. This was a limiting factor in the value of the property and is reflected in the offered prices. Director Clark inquired about the contingencies. Mr. Frye explained that all contingencies, such as inspections and financing, related to the two entertained offers have been removed. Director Goold asked for elaboration on the efforts made with the local Park District. Mr. Frye shared that due to the zoning there was only one buyer, which is the Park District for that area. They submitted interest, and explored purchasing the property, ultimately voting not to move forward with the purchase.

President Jones opened the floor for Public Comment.

Mrs. Jane Schultz commented to the Board, first by thanking the Sacramento Metropolitan Fire District for their professional selfless support to the community. She has lived on Dredger Way for forty years and enjoyed the proximity of Firehouse 33 on several occasions. She is concerned what may take the place of the fire station after the sale. She voiced concerns that the community was not informed of the sale, and inquired why the land and firehouse are packaged together.

Mrs. Lynne Holmberg-Gray shared with the Board that the neighbors have questions. Their worst nightmare would be for someone to destroy the wildland community, and build an apartment complex, bringing more traffic and causing destruction to the wildlife. She asks if there is a parcel map that neighbors can view, if neighbors can be more involved in the process, and who is going to purchase the property and what is going to happen in the future.

Mr. Guy Gillen commented that several homes border this property. His understanding is the parcels were deeded to the Fire District to take care of for the community. He provided three photos showing the overgrowth of the open space. He requested whoever purchases the property be made aware of the upkeep that is required.

Mr. David Moskat shared with the Board that he is a homeowner that borders the green belt. His family is concerned for the habitat loss, increased noise, and loss of privacy, or unsightly fence that may come from development. He would like for more time to influence the Park District to purchase the property.

Director Goold makes a motion that this item be tabled and additional information gathered and the community is engaged in the process.

Discussion among the Board Members and Economic Development Manager Frye takes place. Information regarding the repercussions of extending the current process, details of the sale specific to the current offer, and participation from the community regarding zoning of open space, is dicsussed.

Director Goold rescinds him original motion, and makes a motion that the Board reject staff's recommendation at this time. The Board does not second this motion.

Mr. Vern Perrin requested to approach the podium from the audience and shared with the Board the importance of the wildland ecosystem that exists on the seven acre piece of land.

# 2. Replacement Wildland Personal Protection Equipment Purchase (Deputy Chief Bridge)

**Recommendation:** Authorize staff to purchase 600 sets of Wildland PPE for an amount not to exceed \$320,000.

**Action:** Moved by Goold, seconded by Saylors, and carried unanimously by the members present to authorize the purchase of 600 sets of Wildland PPE not to exceed \$320,000.

# 3. Nomination of Special Districts Representative for the Sacramento County Treasury Oversight Committee (Deputy Chief Casentini)

**Recommendation:** Consider nominating one candidate for special districts representative for the Sacramento County Treasury Oversight Committee.

#### **OPERATIONS REPORT**

Deputy Chief Bridge thanked Captain Grant Russel for being in attendance and being able to answer questions related to the Wildland PPE purchase. Captain Russel and crew are available out front in the new Type III and Type IV Engines. DC Bridge continued with the Operations Report letting everyone know as of March 28<sup>th</sup> Metro Fire responded to approximately 4,000 calls, of which 3,000 were EMS related with a transport rate of 75%. He also relayed that there have been 13 building fires. There have been approximately 23,000 total incidents since January 1<sup>st</sup>, which is slightly under when compared to the first quarter of last year, which was 24,000 calls.

The captain's exam concluded today with 32 candidates starting the process, hopefully everyone is successful. We will see some promotions of the future leaders of the organization in the near future.

**SUBJECT:** Surplus Extrication Equipment

#### **BACKGROUND**

Staff is seeking Board approval to surplus extrication equipment.

#### DISCUSSION

Metro Fire purchased new extrication equipment in 2018 to replace old Hurst equipment. This proposed equipment to surplus is over 20 years old, in need of a major overhaul, or broken, including one with a current book value. Staff proposes to identify the best of the replaced equipment and donate sets to regional fire/rescue agencies. The remaining will be put on auction in attempts to sell. Unsold and broken equipment will be disposed as waste.

#### FISCAL IMPACT

All assets except one has no book value. One broken item to be disposed has a book value of \$6,081. For purposes of our fund financial statements this item was already fully expensed in the year purchased, hence there is no fiscal impact in the current fiscal year. Any proceeds from auction on other surplus items will be deposited into the general fund.

#### RECOMMENDATION

Staff recommends adoption of the attached Resolution to dispose the listed extrication equipment.
