Population Growth and Deviations

The US Census has released in a "Legacy Format" the data from the decennial census, identifying the whole count of persons and where they resided as of April 1, 2020. Redistricting Partners has concluded the work of placing this data into the census blocks, block groups, and tracts.

This data represents the whole population data prior to a state required reallocation of prison population that will be conducted by the Statewide Database at UC Berkeley. This adjusted data will be completed in the coming weeks and updated counts will be provided at that time.

Based on this data, the district has grown by 71,970 counted residents, or 11.1%, since the last redistricting. All nine divisions saw an increase in population. The highest increase was seen in Division 4 with a gain of 16,198 counted residents and a growth rate of 24.1%, while Division 3 experienced the slowest growth rate at 4.1%.

Census Populations and Growth

Prior to the prison reallocation dataset and with a districtwide population of 719,641, the ideal population for any division be 79,960. The seat with the largest population is Division 6 at 88,009 (+10.1%) and the smallest is Division 9 at 68,601 (-14.2%), placing the district with a total deviation of 24.3%, well above the 10% deviation range maximum.

2020 Census Population and Deviations

The data used to determine the size of ethnic and racial subgroups utilized for Voting Rights Act calculations, have been finalized for the current redistricting cycle. As with the 2010 data, this does not show significant ethnic population that will require divisions to be drawn in any specific construction to comply with the VRA.


Current Citizen Voting Age Population
