The Governor has also issued Executive Order N-33-20, prohibiting people from leaving their homes or places of residence except to access necessary supplies and services or to engage in specified critical infrastructure employment.

Chief Harms informed the Board the Captain's promotional process is concluding today, and they anticipate having the eligibility list released tomorrow. We are looking forward to welcoming the future leaders to the rank of Captain.

6/15 Captain's Academy – Welcomed 26 candidates at Station 106. This was a week-long academy to prepare candidates for their potential new positions. Chief Harms opened the academy on Monday by answering any questions they had.

Chief Harms concluded by giving an update on behavioral health. Jeff Wells has seen an increase in the number of members reaching out. This can be attributed to the confidence in the program, especially during a pandemic.

OPERATIONS REPORT

Deputy Chief Bridge reported that although we are faced with challenging political and environmental times, our members are still showing up to work and signing up for overtime shifts. Call volume has returned to regular numbers and fire volume is up, mostly due to the increase in vegetation fires.

The Operations Division is up staffing for the 4th of July holiday weekend, and will increase the number of arson investigators, presence on the American River, busier engine companies, and Copter 2.

He concluded by reporting on the 5,000 acre grass fire that occurred on Friday, June 12th near Jackson and Grant Line Road. Overall, 28 Metro unit responded, and worked closely with Cal Fire, 3 helicopters, and 5 tankers. They lost one outbuilding during the fire.

Captain McGoldrick is happy to report a successful Captain's promotional exam process, and thanked the internal personnel and external evaluators for their time and dedication. Members are rising to the occasion during this pandemic and taking care of each other and members in the community.
